### **Notes**

The Schemes administered by TPT are occupational pension schemes of the type generally known as 'defined contribution' or 'money purchase'. It is a Registered Pension Scheme for the purposes of the Finance Act 2004. The Pension Scheme Tax Reference is 00281218RV.
